ALL HOME OCCUPATIONS MUST COMPLY WITH THE FOLLOWING REQUIREMENTS OF ZONING ORDINANCE 17.04.470 (please initial) A. "Home occupation" means an occupation performed wholly within a residence or the yard and accessory buildings being a part of such residence. Home occupations shall not change the character of the residence or the residential neighborhood. A business license is required for some home occupations. They shall be issued for a one-year period and are renewable. The City Council may review a license in reaction to neighbor's complaints and may revoke it if evidence warrants this action.
B. Two levels of home occupations exist. Both are required to maintain all of the

		4.	No outside storage of goods or materials is permitted.	
		5.	Pedestrian and vehicular traffic will not be in excess of that normally

		6.	One sign will be permitted on the property. It must meet the requirements	
		7.	of 17.72.010 "Name Plate".
