A RESOLUTION AMENDING AND ADOPTING THE HYRUM CITY SQUARE PAVILION, SALT HOLLOW PARK PAVILION, BLACKSMITH PARK PAVILION, AND AJ'S PARK RENTAL FEE AND DEPOSIT SCHEDULE.

WHEREAS, Hyrum City owns park property that have pavilions for citizens to use known as the City Square, Salt Hollow Park, Blacksmith Park, and AJ's Park; and

WHEREAS, Hyrum City has determined to allow these pavilions to be rented for a variety of public and private functions; and

NOW, THEREFORE, be it resolved that the Hyrum City Council hereby approves and adopts the Hyrum City Square Pavilion, Salt Hollow Park Pavilion, Blacksmith Park Pavilion, and AJ's Park Rental Fee Schedule attached hereto as Exhibit A. These fees may be revised from time to time by resolution.

RULES

1. All Group Events over 100 people require:
 - A. Mass Gathering Permit;
 - B. Liability Insurance Policy for a minimum of \$1.0 million; and
2. All inflatable bounce houses must be pre-approved by Hyrum City at least one week before event and accompany a 1 million dollar insurance policy in which Hyrum City is named an additional insured.
3. No asking other people using playground equipment, or splash pad to leave or telling them you have you have entire area reserved.
3. No alcoholic beverages, including beer is allowed.
4. Place all garbage in containers.
5. No dogs.
6. Those reserving pavilion is responsible for any damage to city property.
7. No overnight parking or camping at this park.
