

RESOLUTION 16-11

A RESOLUTION AMENDING THE BAIL SCHEDULE FOR TITLE 6 THE ANIMAL ORDINANCE OF THE HYRUM CITY MUNICIPAL CODE.

WHEREAS, Title 6 of the Hyrum City Municipal Code sets forth those regulations and conditions governing the keeping and use of certain kinds of animals within the limits of Hyrum City; and

WHEREAS, in Title 6 of the Hyrum City Municipal Code it includes specific provisions and conditions regulating the fines and penalties for any person found guilty of violating any or engaging in prohibited activity; and

WHEREAS, the Hyrum City Council has concluded, upon the recommendations of animal control personnel and court staff, there is a need to amend and approve the fine and bail schedule for violations of Title 6 of the Hyrum City Municipal Code.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hyrum, Cache County, Utah, that the Bail Schedule for Title 6 Animals of the Hyrum City Municipal Code is hereby amended as follows:

All violations, including but not limited to those listed above, of Title 6 Animal of the Hyrum City Municipal Code are Class C Misdemeanors and can carry a maximum penalty of \$1,060 and jail time of a maximum of 90 days.
