RESOLUTION 16-10

A RESOLUTION SETTING CULINARY WATER RATES.

WHEREAS, Title 13 of the Hyrum City Municipal Code sets forth regulations governing municipal utility services; and

WHEREAS, Chapter 13.04, Section 13.04.050, of the Hyrum City Municipal Code, authorizes periodic adjustments to municipal culinary water rates by resolution of the governing body; and

WHEREAS, the culinary water reserves have decreased 58% over the past five years and electrical power costs have increased 24.7%; and

WHEREAS, other operation and maintenance costs have increased resulting in depletion of water reserves; and

WHEREAS, Hyrum City's 40 Year Master Plan indicates the needs for an additional culinary water storage; and

WHEREAS, current rates are insufficient to generate the capital necessary for system improvements and on-going operation and maintenance costs;

WHEREAS, after careful consideration and review of the financial requirements of the culinary water system, the governing body has determined it is both necessary and proper to increase user rates on culinary water service.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hyrum City, Cache County, State of Utah, that the user rates for water service from the municipal culinary water system shall be as follows:

1. CULINARY WATER RATES INSIDE HYRUM CITY LIMITS

- A. The minimum monthly rate for 10,000 gallons of culinary water for single family dwellings as metered through a 3/4-inch meter shall be \$12.00.
- B. The minimum monthly rate for 10,000 gallons of culinary water for multi-unit dwellings, mobile home parks, and master metered P.U.D.s shall be \$12.00 per

each unit or mobile home regardless of the master meter size.

C. All other water connections shall be charged per the following schedule:

2. OVERAGE CHARGE - RESIDENTIAL

- A. For all water used by residential and agricultural users in excess of 10,000 gallons, the monthly overage charge shall be:
 - \$.68 per 1,000 gallons from 11,000 gallons through
 50,000 gallons per month.
 - \$.98 per 1,000 gallons for all water used over 50,000 per month.
- B. For master-metered multiple dwelling units and mobile home parks, the overage charges under (a) above shall apply to all water used exceeding the total of 10,000 gallons per unit and shall be billed to the owner or other responsible party.

3. OVERAGE CHARGE - COMMERCIAL & INDUSTRIAL

- A. For all water used in excess of 10,000 gallons, the monthly overage charge shall be:
 - $\frac{68}{.68}$ er 1,000 gallons from 11,000 gallons through 50,000 gallons per month.
 - $\frac{5.80}{50,000}$ per 1,000 gallons for all water used over 50,000 gallons per month.

4. WATER RATES OUTSIDE HYRUM CITY LIMITS

A. For all Hyrum City culinary water furnished outside Hyrum City limits, user fees shall be one and one-half (1 1/2) times the rates established for use within city limits.

BE IT FURTHER RESOLVED, that this resolution shall become effective on March 1, 2016.
